Note: Actual/Assessed Valuation is multiplied by a Rollback Percentage to get to the Taxable Valuation to calculate Property Taxes. Residential and commercial properties have the same rollback percentage through \$150,000 of actual/assessed valuation.

Reasons for tax increase if proposed exceeds the current:

Increase in amounts necessary for tax levies of Liability Property Self Insurance, Support of Local Emergency Mgmt. FICA & IPERS and Other Employee Benefits. Also increase in Debt Service Levy for repayment of Debt.
