and the increase in activity at the park it is a safety concern. The council directed that the police department review the intersections and come up with a plan. Council thanked those who voiced their concerns and supported their commitment.

RESOLUTION 2025-06: Approving the Authorizing Internal Advance of Funds for Payment of Urban Renewal Projects: The resolution includes that Preston shall certify the total amount \$25,843 for the Plastics Unlimited Development Agreement. A motion was made by approve Resolution 2025-06 by D.Meyer, seconded by M. Gerardy. motion carried.

ANNUAL URBAN RENEWAL REPORT FY24/25: Ganzer explained that report was completed by Kelley Brown, ECIA on Preston's behalf based on last fiscal year's numbers. The TIF Special Revenue Fund Cash Balance is \$20,298 and outstanding TIF Obligations is 412,777. This report is submitted annually to the Dept. of management. A motion was made to approve the report by L. Budde, seconded by D. Meyer. Motion carried.

RFI/RFP Builder & Developer Engagement letter: As discussed at the last meeting council reviewed draft letter by Ganzer to approve sending out letters to contractors in attempt to gain interest in building at Harvest Heights. Meyer asked that Ganzer explore idea of having EICC students build in Preston. They will let us know if any programs they offer fit our needs. Approval of sending letters as drafted be sent and followed up with at the first of the year.

GOAL Review Workshop: A workshop will be held on Thursday with Marc Rudin to review and prioritize projects to assist in proceeding with the engineering plans.

OTHER BUSINESS:

Department Updates were reviewed including.

Goerdt Inspection Services Update: Ganzer reported on the status of the first round of violations that were addressed and responses. The direction of next steps was considered and Ganzer was directed to follow up with Terry Goerdt.

WPPI Member Contributions: Remaining funding available for 2025 were presented and recommendations were to provide Community Contributions to the Preston Holiday Festival - \$750, EV Marching Band fundraising efforts - \$750 and EV Shop with a Cop contribution - \$800. All were in agreement to distribute funds accordingly.

Dispatching services/911 update: Ganzer attended the county meeting where the Board of Supervisors, Maquoketa Police and City Clerks/Administrators discussed a proposed agreement and investigation of having the county take over the 911 service. There will be a follow-up meeting to present other options with an agreement that cities and the county are committed to funding the costs of these services.

City Tourism Map: A committee of people worked on flyers that included a map of businesses and services offered in and around Preston. The map and flyers are ready to go to print to promote Preston. Thank you to the Committee for all their work.

With no further business to be discussed, a motion adjourn was made by A. Reuter, seconded by L. Budde motion carried. Meeting adjourned at 7:05p.m.
