GUEST MARC RUDEN, IIW: M. Ruden advised Council that a Resolution is required to set the Public Hearing on proposed plans, specifications, forms of contract, estimated costs and taking of bids for the Wastewater Treatment Facility 2020 project.

RESOLUTION 2021-02: M. Petersen made a motion to approve Resolution 2021-02 as presented. R. Petersen seconded the motion. Ayes: MP, PH, RP, AR. Nays: 0. Motion carried.

CATALYST GRANT: P. Hoffman provided an update from Nic Hockenberry, JCEA. JCEA and Preston Times are in the predevelopment stage. Preston Times has signed a service contract with 563 Design to assist with design and architecture work on the project. JCEA is working with Preston Times to secure Revolving Loan Funds to assist in the financing of the rehabilitation project.

SIDEWALK REPLACEMENT/HEALTHY HOMETOWN: T. Sieverding advised Council that the financial impact on Road Use Funds (RUT) has not been as significant as what was predicted. T. Weinschenk stated that in the month of June the dollar amount was lower but the amount received for RUT at this time appears to be back to normal. These funds can be used for a sidewalk incentive program. Council tabled until next meeting. P. Hoffman provided an update on the Healthy Hometown Initiative powered by Wellmark. Preston needed 8-11 people on the committee. P. Hoffman stated that she has 11 people. This committee would be visionary people. The next step is for Aaron Swanson (our contact person from Wellmark) will select a few people to reach out to via email in the next couple weeks to set up a short telephone call to help him get a better understanding of our wonderful community and also see what questions some team members have. He will not be reaching out to everyone but just feels a

sampling of individuals gives him a better idea of how we can most effectively and efficiently work together going forward. it is most likely that our meetings will take place via GoToConnect or Zoom (virtual meetings).

PUBLIC HEARING FOR SPECIAL PERMIT: T. Weinschenk advised Council that there is a request from Archie McNeil requesting a special permit for Lot 5 of McNeil's Second Addition. McNeil would like to sell the lot to the Vance's so they can put up a garage for the semi. At this time there would not be a single-family house constructed. T. Weinschenk stated that this is following the process by setting a Public Hearing for the August 24, 2020 Council Meeting. R. Petersen made a motion to set the public hearing. M. Petersen seconded the motion. Ayes: RP, MP, PH, AR. Nays: 0. Motion carried.

GENERAL UPDATE ON PARKS: T. Sieverding stated that the fundraising has been difficult due to the Covid-19 virus. However, the Edgewood Locker fundraiser has been well received and went very well. The proceeds of the fundraiser will go towards the Peppermint Park project. P. Hoffman gave an update on Westside Park/Walking Path stating that the final details are being put in place. Signs have been ordered to give recognition to donations. Lights have been put on the back of the park restrooms to illuminate the signs that will be posted there along with an enclosed bulletin board. The pet waste receptacles have been installed. We will be ordering and installing soap dispensers and hand driers for the bathrooms. M. Petersen thanked the committee and volunteers for everything they have done and appreciate all the hard work.

JACOB PETERSEN: Council thanked Jacob Petersen for the great job he did while he worked for the City part-time this summer.

MAYOR SIEVERDING noted that there is a vacant Council seat that needs to be filled. If anyone in the public is interested or knows someone that would possibly be interested please call City Hall.

Mayor Sieverding requested a motion to adjourn. Motion made by R. Petersen. Seconded by P. Hoffman. Ayes: PH, RP, AR, MP. Nays: O. Meeting adjourned at 6:50 p.m.
