Regular City Council Meeting

February 8, 2021

Mayor Tyler Sieverding called the meeting to order at 6:02 p.m.

The Pledge of Allegiance was recited by all.

ROLL CALL: Present A. Reuter, M. Petersen, M. Gerardy, R. Petersen

OTHERS PRESENT: Deputy Clerk, Sheryl Ganzer

APPROVAL OF AGENDA: Motion was made by M. Gerardy to approve the agenda. Seconded by R. Petersen.

Ayes: AR, MP, MG, RP. Nays: 0. Motion carried.

CITIZEN/PUBLIC COMMENTS: None

CONSENT AGENDA: R. Petersen questioned the invoice for the Rust Protection for new GMC, council determined prior approval for the work being done and that it was not included in the purchase of the truck. Motion was made by M. Petersen to approve the consent agenda with correction to the Minutes of the Feb. 1, 2021 meeting noting to remove M. Petersen from ROLL CALL and APPROVAL OF AGENDA, due to M. Petersen was absent for the 2/1/21 meeting. Seconded by R. Petersen. Ayes: RP, AR, MP, MG. Nays: 0. Motion carried.

RESOLUTION 2021-18 a Resolution setting the date for public hearing for Feb. 22, 2021 on proposal to enter into a General Obligation Corporate Purpose Loan Agreement and to borrow money thereunder in a principal amount not to exceed \$1,400,000.00. Mayor Sieverding informed council, that T. Weinschenk voiced concern to I/W Engineer, Marc Rudin regarding the asking price of 1.4 million being insufficient to cover all the utility expenses. Rudin explained, due to the majority of the Gas and Water work being done by the City, the asking price would be adequate. Motion to approve Res. 2021-18 was made by R. Petersen, seconded by A. Reuter. Ayes: MP, MG, RP, AR. Nays: 0. Motion carried.

RESOLUTION 2021-19 to fix date for public hearing on proposal to enter into a Sewer Revenue Loan and Disbursement Agreement and to borrow money thereunder. Motion to approve was made by M. Petersen, seconded by M. Gerardy. Ayes: MG, RP, AR, MP. Nays: 0. Motion carried.

OTHER BUSINESS: R. Petersen asked the status of placing part time police officers. S. Ganzer responded that to date, no one has taken the position and that Chief Thayer is continuing to look for candidates. M. Petersen gave kudos to the City Staff for their efforts in dealing with all the snow and keeping the streets clear. R. Petersen asked if anyone had shown interest in filling the newly vacated council seat. Mayor Sieverding responded that no one has come forward yet and will continue efforts in finding potential candidates. M. Petersen noted he was approached by one interested party. Council has 60 days to fill the vacancy.

With no other business Mayor Sieverding requested a motion to adjourn. Motion made by M. Petersen, Seconded by A. Reuter. Ayes: RP, AR, MP, MG. Nays: 0. Meeting adjourned at 6:15 p.m.
