UPDATE ON WASTEWATER TREATMENT FACILITY: Marc Ruden from Origin Design, informed Mayor and Council that the walk thru went well. The final walk-thru will be in the next week or two to sign off on final completion. The landscapers are out at the WWTF now. There is a little add on that Ruden will meet with Mitch (A&G Electric) and Preston to decide how we want it done. This would be outside of the contract.

WWTF, PAYMENT NO. 7: A. Reuter made a motion to approve Payment No. 7 in the amount of \$44,609.15 for Staab Construction. M. Gerardy seconded the motion. Motion carried.

UPDATE ON MARVIN ADDITION: Marc Ruden from Origin Design, informed Mayor and Council that things are moving along. Right now, BWC is working on the sanitary sewer. At the last progress meeting (7/29) BWC has completion as of September 17th. Mayor Sieverding and Council member JT Thomson attended the meeting. It was discussed that Mayor and Council do not want this to exceed an extension of 30 days (October 1). Ruden stated that the extension is a good faith effort to get it done. JT Thomson stated that we just want it done right. Council agreed with the statement. Mayor Sieverding stated that originally BWC had stated they would bring in a second crew. Also, have they worked any Saturdays? M. Ruden is going to monitor and will report back.

MARVIN ADDITION, PAYMENT NO. 2: A motion was made by R. Petersen to approve Payment No. 2 in the amount of \$37,050 to BWC Excavating. Second made by JT Thomson. Motion carried.

CHANGEORDER NO.1 FOR BWC EXCAVATING: A motion was made by JT Thomson to approve Change Order No. 1 for the additional cost to increase the PCC Pavement from 6" to 7". Matt Gerardy seconded the motion. Motion carried.

BUILDING PERMIT: The Council is in favor of the building permit for 243 N. Simpson Street. Council would like to see it moved further to the East. Weinschenk stated in a conversation with Traxel he is willing to do that. Traxel had stated that he is getting the property surveyed. Council tabled the item until next meeting when the survey has been done.

STREET SWEEPING FOR MILES: Council feels that this is a day-to-day operations decision. David Michel and Weinschenk can decide. Weinschenk will check the IDOT website and see if there is a per hour cost

listed. Mayor and Council feel this is being a good neighbor. A. Reuter requested to continue to bring up to Council if other requests come in.

BLUE LINE SOLUTIONS: Miles is requesting the City of Preston to sponsor Blue Line Solutions for their town. Blue Line Solutions provides speed cameras at no cost to the city. Council questioned who would receive the revenue? What is the responsibility of Preston? Chief Pirtle said that he did not have answers to these questions. Chief Pirtle called four different phone numbers and could not reach anyone. Weinschenk explained that Mayor Johnson from Miles was out of town. Council tabled the item requesting that Weinschenk extend an invitation to Mayor Dane Johnson to attend the August 23rd Council Meeting.

RESOLUTION 2022-05 AUTHORIZING THE LEVY OF TAXES TO PAY THE ISSUANCE OF A \$265,000 TAXABLE GENERAL OBILIGATION PROPERTY ACQUISITION NOTE: A motion was made by R. Petersen to approve Resolution 2022-05. Seconded by A. Reuter. Motion Carried.

ENGAGEMENT LETTER WITH AUDITING FIRM, O'CONNOR & BROOKS: Weinschenk explained that this would be an examination and not a full audit. Council agreed that this was acceptable. A. Reuter made a motion to sign the engagement letter with O'Connor & Brooks. M. Gerardy seconded the motion. Motion carried.

EASTON VALLEY BOOSTERS: A motion was made by M. Petersen to approve donating \$100 to the Easton Valley Boosters for their golf outing. R. Petersen seconded the motion. Motion carried.

OTHER BUSINESS: Mayor Sieverding stated that the City has received the first half of the Federal Funding. Carol Kilburg's house is coming along, the foundation is in. Nic Hockenberry has resigned from JCEA. Weinschenk stated that the city is receiving four new laptops and four webcams through the CARES Act state funding of \$9,500. Chief Pirtle reviewed Police Reports with the Mayor and Council. Also stated that the 2015 squad is at Westside and will be looked at 8/10, the Jackson County Sheriff's Dept will be using the gun range in three weeks, Adam McPherson is assisting with police coverage every other weekend and some weekdays.

Mayor Sieverding requested a motion to adjourn. Motion made by R. Petersen. Seconded by A. Reuter. Ayes: RP, AR, JT, MG. Nays: 0. Meeting adjourned at 7:05
