APPROVAL OF PAYMENT REQUEST NO 1 AND CHANGE ORDERS NO. 1, 2, & 3: Marc Ruden with Origin Design informed Mayor and Council that the contractor is finishing up on the Sponsored Project. There is some rip rap to do, seeding and erosion control. The contractor will come back in the Spring to finish the swale on the south side of the football field. JT Thomson made a motion to approve Payment

89,149.35

Request No. 1 and Change Order No. 1, 2, and 3 to the contractor. A. Reuter seconded the motion. Motion carried.

BIL SRF GRANT FUNDING: Marc Ruden, Origin Design, reviewed the possibility of some grant funding that is coming from the Federal level to the State for sewer and water. Ruden explained how Preston is ranked and what qualifies as a priority project. If you do not have a project that is listed in their priority project list, you are not eligible. At this time Preston does not have an eligible project. Ruden wanted Council to be aware of this funding. Weinschenk will get with Tim Morehead and see if we have any sewer deficiencies that may qualify as a project.

MCNEIL SUBDIVISION STORM SEWER: Weinschenk stated that Preston is not eligible for any grant funding through the USDA since Preston's median income is too high. Weinschenk has been working with ECIA to see if there is any other grant funding available. There is a CDBG (Community Development Block Grant) that Preston could apply for which has grant funding up to \$500,000. The remaining amount needed could then be a USDA Loan. We do get one free grant writing from ECIA that could be used for writing the CDBG Grant. (Preston was awarded a \$500,000 CDBG Grant for the Lagoon improvements in 2020.) Weinschenk will continue to keep Mayor and Council updated.

APPROVAL RESOLUTION 2022-65 ADOPTING THE ANNUAL STREET FINANCE REPORT FOR FISCAL YEAR 2021/2022: R. Petersen made a motion to approve Resolution 2022-65. M. Gerardy seconded the motion. Motion carried.

APPROVE RESOLUTION 2022-66 AUTOHRIZING AND APPROVING AN AMENDED LOAN AND DEISBURSEMENT AGREEMENT AND PROVIDING THE ISSUANCE AND SECURING THE PAYMENT OF \$951,547.56 SEWER REVENUE IMPROVEMENT AND REFUNDING BONDS, SERIES 2022: A. Reuter made a motion to approve Resolution 2022-66. JT Thomson seconded the motion. Ayes: R. Petersen, M. Gerardy, A. Reuter, JT Thomson.

DRAINAGE DITCH AT THE CATHOLIC CHURCH: Mayor and Council discussed the drainage ditch at the church not being completed yet. JT Thomson stated that in the future the projects should have established deadlines. After much discussion, it was decided to see if the project happens yet this year and if it doesn't to put it back on the agenda in the Spring.

COUNTY LINE CONCRETE QUOTE: Discussed the concrete quote for the shared Fire and Police Department building across the street and that it is an unbudgeted item. A. Reuter and JT Thomson stated it could go in the budget for next year. It was agreed by Council to put it in the budget for next year.

STORM SEWER ORDINANCE ESTABLISHING A STORM SEWER UTILITY FOR THE CITY OF PRESTON: JT Thomson made a motion to approve the first reading of Storm Sewer Ordinance 2022-08. Seconded by A. Reuter. Motion carried. The second and third readings were not waived in order to give the community time to comment.

HARVEST HEIGHTS LOT SALES: Council discussed the options that were presented by Weinschenk in order to contract with Dana Olson who works for Gateway Realty Group. After discussion JT Thomson made a motion to approve sign a 1-year agreement with agent Dana Olson who works for the Gateway Realty Group, charging a flat fee commission of \$1500 per lot for the Harvest Heights Subdivision. M. Gerardy seconded the motion. Motion carried.

OTHER BUSINESS: Weinschenk reported that our agreement with ECIA for the Keep Iowa Beautiful Coach (Hometown Pride) gives Preston one free grant writing per year. This is for beautification and infrastructure. This grant would work for a CDBG grant to assist with the storm sewer. There is also a CAT grant that is for community tourism that would be a possibility for Fitcore. Council would like the free grant writing to go towards a grant for the storm sewer project since it is a necessity. Tim Morehead the Water/Sewer Supervisor provided a list of things that he is going to be working on for sewer and water. Mayor and Council appreciated the update.

With no other business, Mayor Sieverding asked for motion to adjourn. Motion to adjourn was made by M. Gerardy. A. Reuter seconded. Motion carried. Meeting adjourned at 7:15 p.m.
